## The Community Investment Tax Credit

- The Community Investment Tax Credit (CITC) is a refundable tax credit that supports community-led development initiatives and strong local partnerships by leveraging private contributions. Contributions over \$1,000 are eligible for a tax credit up to 50% of the contribution amount. Contribution amounts used to determine CITC eligibility must be reduced by the amount of “goods and services received,” including meals, unless the total value is below the permissible threshold of \$117.00. Please consult your tax advisor for specific tax guidance
